## Communications Potential's Privacy Policy

This privacy policy explains how Communications Potential uses the personal data we collect from you when you use our website.

### What data do we collect?

Communications Potential collects the following data:

- Personal identification information (Name, email address, phone number, postal address etc.)

### How do we collect your data?

**The right to rectification** – You have the right to request that Communications Potential correct any information you believe is inaccurate. You also have the right to request Communications Potential to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Communications Potential erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Communications Potential restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Communications Potential's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Communications Potential transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

- **Functionality** – Communications Potential uses these cookies to recognise you as an unidentified individual as you browse our website throughout your session. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
